Terms and Conditions

- 1. Qurban will be performed in Australia using the facilities of Halal Certified Meat supplier. Amanath Co-op will take utmost care in proper facilitation of the Qurban and on-time delivery of meat to the customers.
- 2. Amanath Co-op undertakes to use a registered and official meat supplier in Australia.
- 3. For Halal Certification and Qurban Supervision, Amanath shall engage the services of the Local Halal Certification Bodies of Australia.
- 4. In case the Qurban process is affected/delayed due to unforeseen circumstances, Amanath reserves the right to delay or cancel part/whole of the Qurban process. In such circumstances, Amanath shall refund to the customers in full or part thereof (if part of cost has already been expended)
- 5. The supervising team at the slaughter house shall ensure that after the slaughter, the specific sheep shall be marked and labelled for packing with respective customer name. However, changes or mistakes may happen unintentionally during this process or in transit which may cause the sheep carcass to be interchanged with another. In such cases, we seek your forgiveness and kind understanding.
- 6. The Quran booking shall be confirmed only after full payment is received from Customers.
- 7. Tentative delivery date of meat in Singapore is on 26th Aug 2018. Amanath reserves the right to change this date due to factors that may contribute to the delay of the Qurban and the shipping process.
- 8. If Customer is unavailable on the scheduled date and time at their selected delivery address, it is the Customer's responsibility to make arrangements with Amanath to self-collect the meat. In such circumstances, there shall be no refund of the delivery fee paid.
- 9. While Amanath provides an indicative weight of the sheep carcass upfront, Amanath shall not be held responsible for any variances in weight of the delivered meat. In such cases, we seek your kind understanding.
- 10. Only the meat of the sheep shall be shipped from Australia and delivered. Skins and other internal organs are not included.
